The section also states: "Such proprietor or his agent shall at the same time mail, postpaid, a duplicate of such invoice to the Director of the Department of Game and Fish at Santa Fe."

ALL CLASS "A" LAKE LICENSEES ARE REQUIRED TO PROVIDE A DUPLICATE COPY OF INVOICES FOR ALL FISH REMOVED FROM THE LAKE. THE ONLY EXCEPTIONS ARE THOSE LAKES WHERE NO FISH WERE REMOVED DURING THE CALENDAR YEAR AND/OR THOSE LAKES THAT HAVE A CATCH-AND-RELEASE RESTRICTION.

As you are required by State Statute to provide a duplicate of invoices covering all your lake's sales or donations, please check one of the following:

- Invoices mailed to Department of Game and Fish during the calendar year.
