The statute [Section 17-4-16 NMSA 1978] requires that the proprietor of a lake provide the purchaser or donee of any game fish with an invoice at the time of the sale or donation.

All Class A Lake permittee's are required to provide a duplicate copy of invoices for all fish removed from the lake to the department. The only exceptions are those lakes where no fish were removed during the calendar year and/or those lakes that have a Catch-and-Release restriction.

As you are required, please check one of the following:

- Invoices are attached to this report
