Dear Southwestern New Mexico Sandhill Crane Hunter:

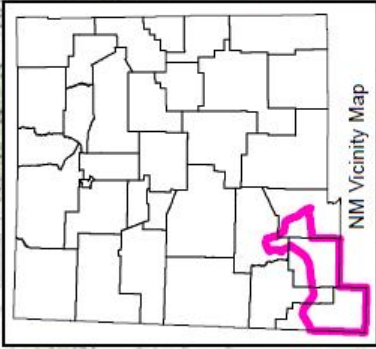
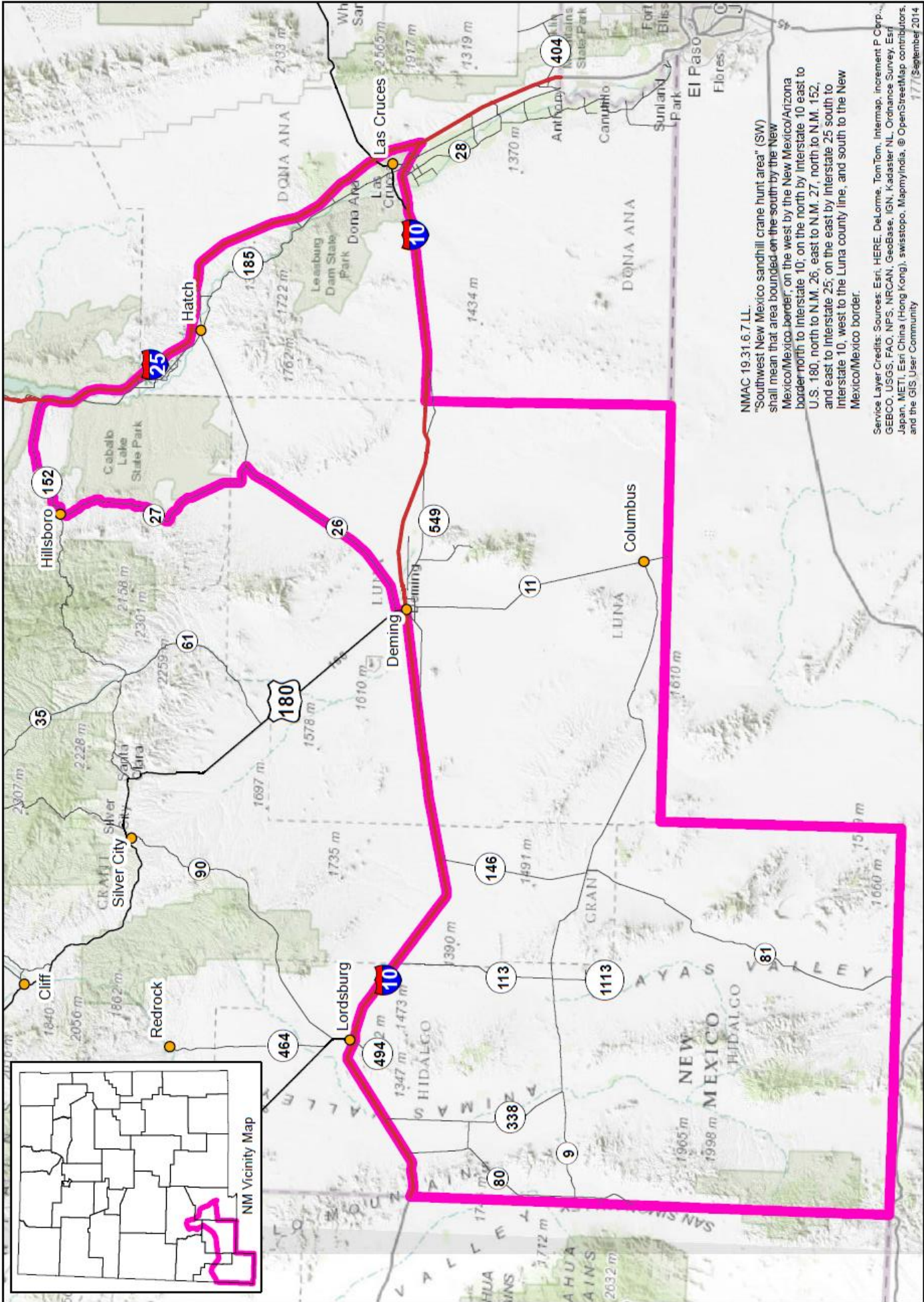
Congratulations, your application was selected for a permit to hunt sandhill cranes during the 2021 Southwest (SW) New Mexico special season, SCR-0-109. Your hunt is scheduled for January 2–3, 2021. The SW Sandhill Crane hunt area is depicted on the map accompanying this letter. The daily bag limit is three (3) cranes with six (6) in possession. Shooting hours are from one-half hour before sunrise to sunset and only non-toxic shot may be used and in your possession.

There will not be a check station for this hunt. All hunters are required to file a harvest report by January 8, 2021 via the Department's online licensing system or by calling 888-248-6866. Successful hunters are additionally required to fill out a bill measurement card for each crane harvested. The bill measurement card accompanies this letter below and these must be returned to the Department by January 8, 2021. The Department is required to monitor the number of greater sandhill cranes harvested to ensure we do not exceed a sustainable harvest. Please follow the instructions on the bill measurement card carefully so that the Department can verify the number of greater sandhill cranes that are harvested. It is critical that you file your harvest report, as any crane or hunter without this corresponding information counts against our state's harvest allotment for greater sandhill cranes. Too many nonreporting hunters could cause crane hunts to close if it appears that New Mexico will exceed its harvest allotment.

IMPORTANT—If you harvest cranes, you must return your bill cards and file a harvest report by January 8, 2021. If you did not hunt or did not harvest any cranes, you still must file a harvest report by January 8, 2021.

A valid hunting license with a Harvest Information Program (HIP) number and a crane hunting permit issued for the correct date and hunt location are required to participate in this hunt. Hunters 17 years of age or younger must also possess their hunter education certification card.

NMAC 19.31.6.7.LL.
 "Southwest New Mexico sandhill crane hunt area" (SW) shall mean that area bounded on the south by the New Mexico/Mexico border, on the west by the New Mexico/Arizona border north to Interstate 10; on the north by Interstate 10 east to U.S. 180, north to N.M. 26, east to N.M. 27, north to N.M. 152, and east to Interstate 25; on the east by Interstate 25 south to Interstate 10, west to the Luna county line, and south to the New Mexico/Mexico border.

Southwest New Mexico Sandhill Crane Hunt Area



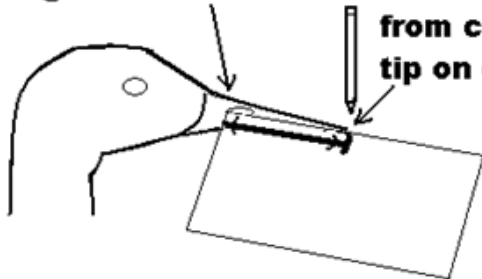


Sandhill Crane Bill Measurement Card

Please print this on card stock. Please do not bend card.

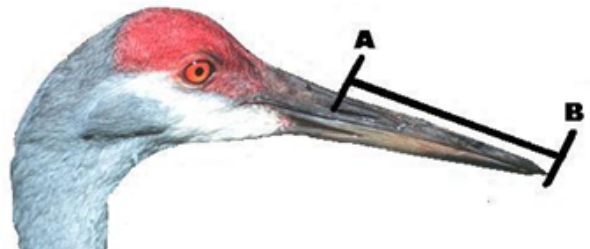
We need a straight-line measurement from the back of an undamaged nostril hole (A) to the tip of your crane's bill (B). Push any corner of this card against the back of an undamaged nostril hole (A) and draw a line on this card at the tip of the bill (B).

Place any corner of the card into an undamaged nostril



Mark distance from corner to bill tip on card

Keep card straight
