Owner's signature(s) must be notarized. The Authorized Ranch Contact is the landowner, company officer or person assigned in writing by the owner(s), to act as the liaison between the ranch and the Department, and is legally responsible for reporting ranch changes, receiving, signing and returning hunting agreements, receiving landowner authorizations, and handling appeal matters.

Pursuant to 19.30.12.8(B)(2)(d) NMAC, if the Department determines there has been a breach of the terms set forth in the hunting agreement, false representation of a ranch's deeded or leased acreage, rightful ownership, or legal representation of a ranch, the Department shall immediately inactivate the ranch, void all unconverted authorizations issued to the ranch, and the owner or authorized ranch contact shall be subject to the processes set forth in 19.31.2 NMAC.

A property in which the landowner or Authorized Ranch Contact's ownership or legal representation is unclear or disputed by another person shall be placed on review pursuant to 19.30.12.7(N) NMAC until such time as rightful ownership or legal representation is determined to the reasonable satisfaction of the Department.
