Return from Executive Session: Upon return from closed executive session, Chairwoman Salazar Hickey announced that during the executive session the Commission discussed only those matters specified in its motion to adjourn and it took no action as to any other matter. In the last item on agenda, regarding matters subject to attorney-client privilege and litigation, the Commission was notified that the Department of Game and Fish filed a suit of declaratory judgement against it under the Declaratory Judgement Act related to 17-4-6 C NMSA 1978 commonly known as the non-navigable statute. The Commission will be represented by the office of the Attorney General and will have no further comment on the matter of non-navigable statute or any other issues related to non-navigable waters.

AGENDA ITEM NO. 10: Presentation of Proposed Easement Agreement for Access to State Lands

Wildlife Management Division Chief Stewart Liley presented the Department's proposed State Land Easement Agreement. The proposed agreement would allow access for licensed anglers, hunters and trappers to State Trust Lands for the 2020-2021 license year.

AGENDA ITEM NO. 11: Initiation of Migratory Bird Rule for 2020-2021 Hunting Season

Wildlife Management Division Chief Stewart Liley presented the Department's proposed changes to the Migratory Game Bird Rule (19.31.6 NMAC) based on public comment, the latest information from the United States Fish and Wildlife Service (USFWS), recent survey information and

management goals. Season selections and bag limits are determined in conjunction with the USFWS working through the Central and Pacific Flyway Councils.

AGENDA ITEM NO. 12: Initiation of Biennial Review of State Listed and Threatened or Endangered Species

Chief of Ecological and Environmental Planning Division Matt Wunder initiated the 2020 Biennial Review of New Mexico state listed threatened and endangered species pursuant to the Wildlife Conservation Act (17-2-40 NMSA 1978).

Motion by: Commissioner Lopez to initiate the 2020 Biennial Review process of assessing state

listed threatened and endangered species.

AGENDA ITEM NO. 13: Operation Game Thief Program

Field Operations Captain Ty Jackson presented an overview of the Department's Operation Game Thief program.

AGENDA ITEM NO. 14: Commission Review of Department Director's Determination of Smith Ranch

Wildlife Management Division Chief Stewart Liley presented the Director's determination for the Smith Ranch. In order to be enrolled as a property in the Elk Private Land Use System (EPLUS), rule (19.30.5 NMAC) requires properties meet a minimum habitat score based upon Commission approved participation guidelines. The Commission approved guidelines require properties must receive a score of at least seven (on a scale from 0-13) in order to qualify. The Los Piedras Ranch owned by Mr. Smith, received a score of five, falling short of the qualifying score. As allowable by rule (19.30.5.12 NMAC), Mr. Smith has requested a Commission Evaluation of the decision that his ranch does not qualify.

Motion by: Vice-chairwoman Salazar-Henry to uphold the Director's determination that the Los Piedras Ranch (Smith Ranch) does not qualify for the EPLUS Program according to the Commission approved guidelines.

Colonel Robert Griego presented the Department's recommendation that the Commission reserve two elk licenses to be distributed through non-profit wish-granting organizations for two individuals with life threatening illnesses.

AGENDA ITEM NO. 17: Discussion on Amendments to the Hunting and Fishing Manner and Method Rule 19.31.10 NMAC

Wildlife Management Division Chief Stewart Liley presented the Department's proposal to delete Subsections DD and EE in the Hunting and Fishing Manner and Method Rule 19.31.10 NMAC to prohibit licensed trappers and cougar hunters from using traps and foot snares to harvest cougars. The purpose of this deletion is to align the rule with the previously passed rule.
