Director Sloane provided the Department's updates:

- The Department darted 14 Rocky Mountain Bighorn Sheep in the Red River area to study disease spread in the population.
- The Department is seeking bids for an 800-acre wetland improvement project at the Bernardo Wildlife Management Area.
- Over the past few months, the hunter education program has enrolled 1,313 youth in hunter education and 151 youth in the Mentored-Youth program.
- During the draw period, the Information and Education Division hosted 15 Facebook Live videos with experts from the Department on wildlife issues holding Q&A sessions.
- The 2022 big game draw produced 121,451 customers, with 275,166 individual applications, which is slightly lower than the 2021 record numbers but well ahead of the 2020 final number.
- A new call system was implemented to support customers during and after the draw period.
- Chapter 17 article 6 authorizes the Commission to allow rules to be put into place with land management agents, to restrict OHV use in wildlife areas and their habitats and to support restoration efforts.
- Chapter 66 of the Motor Vehicle Act includes prohibiting OHVs from driving off-road and provides resources for enforcement and education. This will continue to be a focus for the Department.
- Species guidance assessment shows the round tail chub does not need to be listed.
- Six recruit conservation officers are completing their field training and will be sent to their new districts in June.
- Several officers and fisheries biologists have been helping with the walleye spawn at Conchas Lake.
- Bear hair and den studies were completed across the state with wildlife researchers from New Mexico State University.
- The Field Operation Division continues to work with the state personnel office to update job descriptions, reclassify conservation officer positions and increase officer pay and support.
 This will continue with looking at all employees.
- The Department will begin a statutory review of Chapter 17 to ensure statutes address the needs of wildlife and our citizens. The public process will start with an internal review mid-May and additional meetings made as necessary.

The Commission directed the Department to provide an update on the OHV program and the Department's new website, including the expected launch date, by June 30.
