The State Game Commission discussed a standard for the number of votes required to act on a motion at any and all Commission meetings. The principal question was whether a motion can be acted on by a majority of the quorum present or whether a minimum of four (4) Commissioners is required for a motion to pass. If the quorum is less than seven and a vote is tied, the subject motion will necessarily fail.

Motion: Move that an affirmative vote requires a majority of the quorum present, except those decisions regarding bonding authority under 17-1-18 and those decisions made at hearings under 17-2-5 in its rulemaking authority. Any other issues pertaining to the motions and protocol of its meetings are adhered to under Robert's Rules of Order. Move that this voting standard be documented either in the Open Meeting Act Resolution or another appropriate document as determined at a future meeting and that this standard remain in effect through the end of year or until otherwise amended by the Commission.
