Specifically, the amendments would make private land hunts for desert bighorn ram and Rocky Mountain ram oncein a-lifetime. The other amendment proposed to change the languae regarding the organization that could raffle the bighorn enhancement authorizations from "nonprofit dedicated to the conservation of bighorn sheep" to "an award issued through the state procurement process".
