- archery instructors than anyone else in the country during the first half of 2022.
- Our sportfish education has contacted all APS 2<sup>nd</sup> graders during summer school, bringing their total to over 10,000 contacts for the fiscal year.
- NM Bighorn Sheep Association has sent in over \$148,000 in proceeds from the raffle of the two bighorn sheep tags.
- The Glenwood Hatchery Renovation has concluded. We will be running water through the system and should have fish by August.
- The \$6 million project at Bernardo and LaJoya for waterfowl is underway.
- Ducks Unlimited has agreed to host the Governor's Auction.
- We will be hosting the winter and summer WAFWA meetings in 2023.
- We have hired and/or promoted nine individuals.
- The Governor will be at Bear Canyon at the end of July.
