




OG.163 Access, Pinon, NM



Information: The OG.163 access opens up approximately 5,100 acres on the Lincoln National Forest. Access through this private tract is off of Rim Road approximately 8.5 miles south of where Rim Road turns south from Russell Gap Road. A USFS road to the west accesses this private property access route. The property is located east of Pinon, NM in the Lincoln National Forest.

This property provides access to National Forest lands primarily for deer and elk hunting opportunities. The property itself is not open for hunting, only providing access to National Forest land.

Permitted Activities: Access only is permitted across this property during the seasons and dates specified in the Open Gate lease agreement between the Department of Game and Fish and the landowner. Access dates are also available on the main sign posted on the property. Access across the property is subject to the terms and conditions in the Open Gate lease agreement and is restricted to the following permitted activities:

Access to National Forest only	8/15/23 - 1/15/24 Only. Closed 1/16 - 8/14	Game in this area may include Deer and Elk.


Open Gate is a program that leases private lands to improve public access for hunting, fishing, and trapping. Open Gate leases are funded exclusively by hunters, anglers, and trappers through the purchase of the Habitat Management and Access Validation (HMAV).

OG.163 Access

Property Rules. The following rules will be posted onsite and enforced at the discretion of the Agency :

- Use of this Open Gate Property is restricted to **public travel** on the roads designated for entering and exiting legally-accessible Forest Service and BLM lands for recreational purposes.
- No trespassing unless you are a properly licensed sportsperson, are accompanied by a properly licensed sportsperson or are license-exempt.
- Hunting, fishing, trapping, camping, or trespassing for any other purpose is prohibited on private lands without permission or consent from the landowner.
- No motor vehicle travel off designated roads or on closed roads.
- No destructive acts, including vandalism, graffiti, theft, removal or defacing natural features, resources or signs.
- No target practice.
- No consumption of alcoholic beverages.
- No camping.
- No fires.
- No littering.
- Access allowed from from August 15, 2023 - January 15, 2024.



