**AGENDA ITEM NO. 5: OHV Registration Update --** The Department will present an update on the transition to a mandatory OHV registration display and other efforts with MVD to streamline the registration and permitting process.

**AGENDA ITEM NO. 6: NMDGF Field Officers – Level of OHV Enforcement Effort** – Enforcement of OHV laws is not the primary duty of Department Conservation officers, but is an important component of a wide array of enforcement and biological tasks they perform. Limited budgets and staff availability impact the ability of NMDGF officers to enforce OHV laws at a level desired by segments of the public. The Department and board will discuss ways to meet expectations within available resources and the need and opportunities for additional resources.

**AGENDA ITEM NO. 7: Update on Expansion Positions --** The Department will present updates on the status of requested enforcement coordinator and education coordinator expansion positions.

AGENDA ITEM NO. 8: OHV Safety and a Recent Report on a Downturn in OHV-related Accidents – Presentation and discussion between the Department and Advisory Board on a recent report published by the federal Consumer Product Safety Commission that shows a downturn in OHV-related accidents, including factors contributing to this trend and how New Mexico's efforts can reinforce this trend.
