




2009 Legislative Session Update


- Budget and fiscal matters
 Items on the Governor's "call"
 Legislation vetoed in the previous session
- During a long session, legislators may introduce bills without restrictions.



2009 Commission Approved Legislation



- Operating Budget Request (HB5/2)
- Capital Projects Requests
- Nongame Fish Authority (HB68)
- Penalty Assessment Expansion (HB143)
- Aquatic Invasive Species (HB467)
- Depredation (SB391)





Operating Budget



- The budget begins as HB 5 and is later rolled into HB 2
- The amounts in the bill reflect the Legislative recommendation, including 3.5 expansion positions
- Eliminates all support from the state general fund.
 Last year's appropriation was around \$330,000











Capital Outlay



The Department requested \$12.975 million for 9 projects, and the 3 top priorties in the request were:

OAircraft replacement

- OWarm Water Hatchery
- **OLake Roberts Dam Renovation**





HB 63 Nongame Fish Regulatory Authority



- Sponsored by Rep. Jose Campos
- Do Pass in House Energy & Natural Resources and House Judiciary Committees
- Passed on House Floor by a vote of 67-0
- Referred to Senate Conservation and Judiciary Committees
- Waiting on Senate Hearings



HB 143 Penalty Assessment



- Sponsored by Rep. Elias Barela
- Do Pass in House Energy & Natural Resources and House Judiciary Committees
- Passed on House Floor by a vote of 58-9
- Referred to Senate Conservation and Judiciary Committees
- Waiting on Senate Hearings







- Sponsored by Rep. Don Tripp
- Do Pass in House Energy & Natural Resources Committees
- Referred to House Business and Industry Committee (HBIC)
- Waiting on HBIC Hearing and then to House Floor if successful



SB 391 Landowner Taking



- Sponsored by Sen. Michael Sanchez
- Do Pass in Senate Public Affairs Committee
- Working on Substitute Bill for Senate Judiciary
- Seeking Consensus with Direct Involvement of:
 - OBill Sponsor & Other Senators
 - **ONM Cattlegrowers**
 - **ONM** Wildlife Federation
 - ONM Farm Bureau
 - ONORTHERN NM Stockmen
 - ONM Council of Outfitters and Guides
 - ONM Chapter of Trout Unlimited
