




2010 Legislative Session Update (Episode 1)





Even Numbered Years are 30-Day or "Short" Sessions




- The New Mexico Constitution restricts matters discussed during 30-day sessions to:
 - OBudget and fiscal matters
 - Oltems on the Governor's "call"
 - Classical Content of the previous session
- During a long session, legislators may introduce bills without restrictions.



2010 Governor-Approved Agency Legislation



- Operating Budget Request (HB5/2)
- Capital Projects Requests
- Aquatic Invasive Species (HB113)
- San Juan Stamp (HB51)
- Depredation (HB37)





Operating Budget



- The budget begins as HB 5 and rolls into HB 2
- The amounts in the bill reflect the Legislative recommendation, including a 3.0 FTE reduction
- No support from the state general fund. Last time we had an appropriation (FY 2008) it was around \$330,000
- No budget bill passed











Capital Outlay



 The Department requested \$4.77 million for 7 projects, and the 3 top priorities in the request were:

OWarm Water Hatchery

ODam Safety Rules Compliance

OWMA Facility Improvements

No capital bill passed









HB 113 Aquatic Invasive Species Amendments



Sponsored by Rep. Don Tripp

- Do Pass in House Agriculture & Water Resources and Energy & Natural Resources Committees
- Passed House Unanimously
- Do Pass in Senate Conservation and Judiciary Committees
- Passed Senate Unanimously
- Awaiting Governor's Action



HB 37 Landowner Taking



- Sponsored by Rep. Mimi Stewart
- Do Pass in House Health & Government Affairs Committee
- Was referred to House Taxation & Revenue next
- During Committee report, it was re-referred to the House Business and Industry Committee, where it was tabled



HB 51 San Juan Stamp



- Sponsored by Rep. Tom Taylor
- Do Pass, as amended, in House Consumer & Public Affairs Committee
- Next Referral was to House Energy & Natural Resources Committee
- The Bill Stalled In This Committee
