The Department was made aware of pending legislation to transfer the Valles Caldera National Preserve to the National Park Service. Public comment was heard and largely expressed opposition to a change in management. Discussion centered on the Commission's opposition of moving the Valles Caldera National Preserve to the National Park Service. Following discussion of adherence to the Open Meetings Act, a motion was made to oppose via letter any change of management for the Valles Caldera National Preserve as presented by the Department.

- Public expectation different if NPS

Language in S.285

(a) DESIGNATION AS UNIT OF THE NATIONAL PARK SYSTEM.—To protect, preserve, and restore the fish, wildlife, watershed, natural, scientific, scenic, geologic, historic, cultural, archaeological, and recreational values of the area, the Valles Caldera National Preserve is designated as a unit of the National Park System.

Per Current Law

PURPOSES.—The purposes for which the Preserve is established are to protect and preserve the scientific, scenic, geologic, watershed, fish, wildlife, historic, cultural, and recreational values of the Preserve, and to provide for multiple use and sustained yield of renewable resources within the Preserve

No Immediate Need for Action

Per current legislation report due in 2014.

Final report & recommendation due in 2018.

Current Management Cost approx. \$3 million / year.

SEC. 110. TERMINATION OF THE TRUST.

- (a) IN GENERAL.—The Valles Caldera Trust shall terminate at the end of the twentieth full fiscal year following acquisition of the Baca ranch under section 104(a).
- (b) RECOMMENDATIONS.—
- (1) BOARD.—
- (A) If after the fourteenth full fiscal years from the date of acquisition of the Baca ranch under section 104(a), 16 USC 698v–8.

- (B) During the eighteenth full fiscal year from the date of acquisition of the Baca ranch under section 104(a), the Board shall submit to the Secretary its recommendation that the Trust be either extended or terminated including the reasons for such recommendation.
- (2) SECRETARY.—Within 120 days after receipt of the recommendation
- of the Board under paragraph (1)(B), the Secretary shall submit to the Committees of Congress the Board's recommendation on extension or termination along with the recommendation of the Secretary with respect to the same and stating the reasons for such recommendation.
- (c) EFFECT OF TERMINATION.—In the event of termination of the Trust, the Secretary shall assume all management and administrative
- functions over the Preserve, and it shall thereafter be managed as a part of the Santa Fe National Forest, subject to all laws applicable to the National Forest System.
