- 82% of hunters reported
- 40% successful in harvesting
- Estimated statewide harvest
 - Bulls = 7,881, Cows = 6,238
- Satisfaction rating = 3.62



- Make special drawing for people who turn in game violators



- Make all hunts primitive weapon









- Redistribute antlerless licenses to account for elk distribution across Northcentral landscape
- Add new MB & A hunts in 5B and equally distribute licenses across 4 hunt periods
 - 2 hunts in Oct., 1 hunt in Nov., 1 hunt in Dec.)

 GMU 53: Develop new late (Dec/Jan) hunt in portions of GMU 53 to address elk movement and use




 GMU 55 (Valle Vidal): increase MB licenses slightly resulting from increased recruitment in valle vidal.






- GMU 34 increase in antlerless licenses
- Slightly increase MB licenses in GMU 36




Valles Caldera

- Increase 2nd archery ES hunt from 5 to 7 days
- Change 1st any-weapon Antlerless hunt to Youth Only (10 licenses)
- Eliminate 2nd any-weapon Antlerless hunt & increase simultaneous MB from 15 to 20 (w/5 new licenses on a 4-year rotation)
- Increase all any-weapon Antlerless hunts from 3 to 4 days
- Change 2-person hunt (26 A licenses) to 1-person hunt with 20 Antlerless licenses
- Change mid-Nov. 20 A hunt to women only (20 licenses)
- Archery: No Change; Mature Bull 11% increase;
 Antlerless 3% increase
